Description: Partial amendment to the "Sanitary Technical Regulation for obtaining the certificate indicating whether or not the sanitary notification for processed foods and pesticides or the mandatory sanitary notification for cosmetics and hygiene products is required, and the certificate indicating whether or not sanitary registration for medicines, natural products, medical devices and biochemical reagents is required"

By means of this Addendum No. 2, the Republic of Ecuador advises that the "Sanitary Technical Regulation for obtaining the certificate indicating whether or not the sanitary notification for processed foods and pesticides or the mandatory sanitary notification for cosmetics and hygiene products is required, and the certificate indicating whether or not sanitary registration for medicines, natural products, medical devices and biochemical reagents is required" has been issued pursuant to Resolution No. ARCSA-DE-2022-020-AKRG of 29 December 2022 by the National Agency for Sanitary Regulation, Control and Surveillance (ARCSA, Doctor Leopoldo Izquieta Pérez). The Regulation will enter into force on the date of its signature, without prejudice to its publication in the Official Journal.
