<b>6. Description of content:</b> This regulation is a revised version of the Indonesian FDA Regulation Number 12 Year 2019 on Contamination in Cosmetics. Once this new regulation is enacted, the previous regulation (Regulation of the Indonesian FDA Number 12 Year 2019 on Contamination in Cosmetics) will be revoked.  This regulation sets out general provisions, requirements, contamination limits, tests, sanctions, and an appendix containing contamination limits.  The appendix contains as follows:  1. microbial contamination limits
