It includes appliances like curling combs; curling irons; curling rollers with separate heaters; facial saunas; hairdryers; hand dryers; heaters with detachable curlers; permanent-wave appliances. Appliances covered by this standard may incorporate steam-producing or spray-producing devices.</i>
