<p>5. Title, number of pages and language(s) of the notified document: Draft Resolution of the Cabinet of Ministers of Ukraine "On Amendments to Paragraph 20 of the Technical Regulation on Detergents"; (1 page(s), in Ukrainian)</p>

Description of content: The draft Resolution is aimed to bring the provisions of the Technical regulation on detergents, approved by the Resolution of the Cabinet of Ministers of Ukraine No. 717 of 20.08.2008 (as amended) in compliance with the Law of Ukraine "On the Public Health System" No. 2573-IX of 06.09.2022 with regard to excluding the conclusion of the state sanitary and epidemiological expertise from the list of documents that form the technical documentation submitted by business entities to confirm the compliance of detergents with the established requirements.</p> <p>As of today, Paragraph 20 of the Technical regulation stipulates that the manufacturer or its authorized representative, in order to confirm the compliance of the detergent with the requirements set forth in the Technical Regulation, should form the technical documentation, that includes in particular, the conclusion of the state sanitary and epidemiological expertise of the product issued in accordance with the established procedure.</p> <p>The draft Resolution suggests aligning the provisions of the Technical regulation on detergents with the provisions of the Law of Ukraine "On the Public Health System", which cancels the need for business entities to obtain a conclusion of the state sanitary and epidemiological expertise to confirm the compliance of products with the established requirements from 01.10.2023.</p>
