Description: [House Bill \(HB\) 3043](#) (Oregon Laws 2023, chapter 426) was passed by the Oregon Legislature during the 2023 legislative session and signed into law by Governor Tina Kotek. The law modifies existing statute ([2015 Toxic Free Kids Act](#)). This rulemaking implements certain provisions of HB 3043.
