Description: SAFER CONSUMER PRODUCTS (SCP) REGULATIONS

Listing Nail Products Containing Methyl Methacrylate (MMA) at Concentrations Greater than 1,000 parts per million (ppm) as a Priority Product

The California Department of Toxic Substances Control (DTSC) proposes to change the definition of the Priority Product to exclude nail products containing equal to or less than 1,000 ppm of MMA from the definition of the Priority Product.

Under the proposal initially public noticed on 1 November 2024, manufacturers producing nail products containing 1,000 ppm or less of MMA would have been required to comply with Alternatives Analysis Threshold Notifications (AATNs) and Priority Product Notifications (PPNs) requirements. Under this proposal, those nail products would not be subject to the SCP regulations; therefore, the manufacturers of those nail products would not be required to submit any AATNs nor PPNs.

A public comment period for the rulemaking has been established commencing on 10 February 2025, and closing on 25 February 2025.
